Introduced 27 Bills, 11 passed. (Also, co-sponsored Senate bills in the house.)

Here are the Bills Representative Carlson introduced.

WORK SUMMARY • BILLS I WROTE & SPONSORED (HBs) or CARRIED ON THE HOUSE FLOOR (SBs) THAT BECAME LAW

MENTAL HEALTH SYSTEM IMPROVEMENTS

HB29 - End involuntary commitment to state hospital of people with Alzheimer's, dementia and TBI absent severe mental illness. (Vetoed by the governor, Legislature override 106 to 33)

HB310 - Require spending report of HEART funds
(Healing and Ending Addiction through Recovery and Treatment)

HB557 - Ensure HEART fund use for mental health crisis stabilization

HJ35 - Study of children's mental health services

SB4(Gross) - Tracking abuse and neglect reports at Montana State Hospital.
Vetoed by the Governor, overridden by the legislature 111 to 28)

CHILD WELFARE REFORM / PROTECTING FAMILIES & CHILDREN

HB16 - Faster, more effective, judicial review of child removals

HB385 - Require evidence discovery for all parties in CPS cases

HB513 - Require consideration of harm of removal of children by CFSD

HB555 - Rules for counsel for children in child welfare system

SB148(Lenz) - Require counsel for children in CPS cases

SB182(Lenz) - Create Task Force on Dependent Neglect court system

SB184(Lenz) - Child welfare case timeline reform

SB328(Lenz) - CPS Reform - family integrity

SB339(Bogner) - Establish reasonable childhood independence laws

SB544(Curdy) - Protecting children from pornography on the internet

HEALTH FREEDOM

HB715 - Strengthen school vaccine religious exemption policy

HB334 - Refine school vaccine medical exemption policy

HB702 - Prohibit discrimination based on vaccination status

LAW & JUSTICE

SB38(Brown) - Revising sex offender designations

SB445(Bogner) - Allowing for remote testimony in certain civil proceedings

ECONOMIC OPPORTUNITY

HB353 - Remove license requirement for hair braiding

HB556 - Allow for free-market private daycare

SB199(Hertz) - Food Freedom - allow sale of home grown or prepared food

Representative Caleb Hinkle – His Legislation: 7 presented, 3 passed. These are the 3 that passed.

HB 131 – Remove 24 hour wait requirement for wolf license.

HB 322 – Generally revise laws related to standing masters. REQUIRING STANDING ORDERS TO BE POSTED ON THE DISTRICT COURT'S OR THE JUDICIAL BRANCH'S WEBSITE;

HB 684 – Prohibit the use of vaccination status in certain administration/legal proceedings.

HB 323 – Revise laws related to child protective teams.

HB 324 – Provide for local government expenditure limitations.

HB 762 – Revise laws concerning the best interest of a child

HB 865 – Provide for a local government expenditure limitation and penalties.
